Updated Internet Presentation of BSSSC WG Northern Dimension

The BSSSC has established an ad hoc Working Group for strengthening subregional contribution to the implementation of the Action Plan for the ND and for identifying and intiating concrete actions to the ND.

Objectives

- to strengthen subregional contribution to the implementation of the Action Plan for the Northern Dimension
- to coordinate the BSSSC activities on Northern Dimension
- to follow and to report the BSSSC Board on the development of the Northern Dimension by the European Union, by the Council of the Baltic Sea States and by the national governments in the Baltic Sea Region
- to identify and to initiate concrete actions for the subregional contribution to the Northern Dimension

The first ad-hoc Working Group was chaired by Mr **Hannu Vesa** (Southern Savo Region, Finland, February 1999 until October 2000), the second WG by Mr **Aimo Lempinen** (Uusimaa Region, Finland, October 2000 until October 2001), the third one by Mr **Uno Aldegren** (Skane Region, Sweden, October 2001 until October 2003).

The current and fourth Working Group was established in January 2004. It is chaired by Ms Marjatta Vehkaoja (Regional Council of Ostrobothnia, Finland) and Mr Thomas Pfannkuch (Schleswig-Holstein Land, Germany 2004). In addition, this Working Group has been tasked to follow the new EU policy "Wider Europe – European Neighbourhood Policy" and to investigate necessities & opportunities for political initiatives and/or other related actions on this subject.

Expertise and importance of cooperation on the subnational level is referred to by the Guidelines for a 2nd ND Action Plan (adopted by the Ministerial meeting in Luxembourg, 21 October 2002) as follows:

"Regional and cross-border co-operation and twinning projects should contribute to developing adequate management capability at the regional and local level. The experience of actors at sub-state level such as the Baltic Sea States Sub-regional Co-operation and the Union of the Baltic Cities and the Barents Euro-Arctic Regional Council could be used to ensure better coordination." (para 4.4.3.)
